Compatriot Darrah commented that there is an Unknown Rev. War Soldier buried at the Old Presbyterian Meeting House in Alexandria, VA. Not aware that any notice is given of it by the SAR. President Cunningham appointed him to chair a committee to figure out what to do about the grave and prepare a letter.

It was moved by Compatriot Rex Gradeless and seconded by Compatriot Don Gradeless that the Seth Jewel Charter be reinstated. Pro and con discussion ensued. Question was called and the motion to reinstate the charter passed. President Cunningham told the Seth Jewel Chapter delegates that the chapter must be active within the INSSAR. Because communication within the chapter was a serious problem, Compatriot Rex Gradeless will be the point of contact for the chapter. Secretary was given his email address.

Review of By-Law #3: President Cunningham asked Compatriot Rex Gradeless to write up a revision and forward it to President Cunningham.

Secretary Sharp is to send a notice to all chapter contacts that reporting of various activities is to go to the INSSAR committee chairs. We need to get credit for the activities the chapters are doing.

An annual chapter report was discussed. President Cunningham said that an annual report will be sent to each District Director with the District Director passing that to the INSSAR President and Secretary. With regard to the contents of said report, a committee was appointed to define such: Compatriots Carmichael, Barnhart and Howell.

Compatriot Arnold the national chair of the Patriotic Outreach Committee said that there is a beta version of a new computer game on patriotism being tested. It follows a soldier and the player makes various decisions for the soldier. Many possible outcomes are available as a consequence of the decisions.
